THE WHEEL FOR BROWN COUNTY CIVIL APPOINTMENTS AND FEE REPORTING REGARDING THE 35TH DISTRICT COURT, BROWN COUNTY, TEXAS

Chapters 36 and 37 of the Texas Government Code effective September 1, 2015 requires each court located in a county of twenty-five thousand or more in this state to establish and maintain lists of attorneys ad litem, guardians ad litem, mediators and guardians, and for the clerks of the courts to report monthly the appointments and the payments for those appointed as required by law. In addition, the courts are required to post each list established under Section 37.003 of the Texas Government Code at the courthouse of the county in which the court is located and on any internet website of the court.

The following plan is adopted by Judge Stephen Ellis, Local Administrative District Judge and the presiding judge of the 35th Judicial District Court, Brown County, Texas.

STATUTORY AUTHORITY

This plan concerning the appointments required under the new law enacted by the 84th Texas Legislature is done in compliance with the requirements of the Texas Government Code referenced above.

LISTS OF NAMES

In addition to a list required by other state law or rule, the 35th Judicial District Court for Brown County, Texas has established and will maintain effective September 1, 2015 the following:

- (1) A list of all attorneys who are qualified to serve as an attorney ad litem and are registered with the court;
- (2) A list of all attorneys and other persons who are qualified to serve as a guardian ad litem and are registered with the court;
- $(3)\Lambda$ list of all persons who are registered with the court to serve as a mediator;
- (4) A list of all attorneys and private professional guardians who are qualified to serve as a guardian as defined by Section 1002.012, Estates Code, and are registered with the court.

METHOD

To be placed on the list to serve in any of the above referenced capacities, a person must be "qualified to serve" in that capacity and registered with the court. Those persons placed on the lists for positions that have statutory requirements to serve in that capacity must meet those minimum requirements before being

registered with the court and placed on the lists. Unless requested by a court with jurisdiction in Brown County, Texas, Judge Stephen Ellis as Local Administrative Judge will only be establishing and maintaining the required lists for the 35th District Court in those cases in which are being heard by the presiding judge or any assigned judge for the 35th Judicial District Court. The associate judges of the 35th Judicial District Court shall maintain their own separate lists. At the present time, these judges are: Associate Judge Cheryll Mabray of the Child Protective Court of the Hill Country, and Associate Judge Ken Law, Title IVD Judge. Likewise, the judges of the Brown County Court at Law and the Brown County Constitutional Court and any Justice Court shall maintain their own lists, if needed.

SELECTION OF THOSE APPOINTED

Subject to the exemptions set out in Section 37.002 of the Texas Government Code, in each case in which the appointment of an attorney ad litem, guardian ad litem, or guardian is necessary, the District Court shall use a rotation system and will appoint the person whose name appears first on the applicable lists maintained by the court. On finding good cause, the court may appoint a person included on the applicable lists whose name does not appear first on the list or even someone qualified but not on the lists in a complex case, as per Section 37.004 of the Texas Government Code. A person who is not appointed in the order in which the person's name appears on the applicable list shall remain next in order on the list. After a person has been appointed from the applicable list, the court shall place that person's name at the end of the list. If parties cannot agree on a mediator, then appointment of the mediator will be made from the lists as required by law. Pursuant to Rule 2.4 of the Local Rules of Practice for Brown and Mills Counties, which have been approved by the Supreme Court of Texas, alternate dispute resolution is mandatory unless the court has determined that it is inappropriate for the case. Therefore, those mediators appointed by the court pursuant to the Alternative Dispute Resolution System established by the courts for Brown and Mills Counties are governed by one of the exceptions set out in Section 37.002 of the Texas Government Code.

OFFICIAL IN CHARGE OF REPORTING

The District Clerk of Brown County, Texas is designated as the official to be in charge of the reporting requirements of those persons appointed and any payments made to them as required by law. In addition, the District Clerk is directed to post each list established and maintained for the 35th District Court and any of its associate judges. These lists shall be posted at the Brown County courthouse and on any internet website maintained by Brown County or the District Court. The lists shall be annually updated by December 31 of each year. The District Clerk is directed to record a copy of this plan in the Administrative Minutes of the District

Court and furnish a copy of it to the judges and associates judges of all courts in Brown County, Texas. A copy of the plan shall also be posted by the clerk along with the lists as referenced above.

EFFECTIVE DATE

This plan became effective on September 1, 2015, but it was reduced to writing in October 2016. The reporting requirements as per Section 36.004 of the Texas Government Code became effective September 1, 2016. Therefore, the first report to the Office of Court Administration for September is due October 15, 2016.
