Approximately 75% of the receipts will be realized through a proposed ad valorem tax of .49482 cents per \$100 of assessed valuation. The remainder of the receipts will come from other local sources, fund balances, and state payments.

BROWN COUNTY PROPERTY TAXES WILL BE INCREASED BY THE ADOPTION OF A TOTAL TAX RATE OF 0.49482.

General Fund Rate	0.39624
Debt Service Rate	0.02385
Road and Flood Rate	<u>0.07473</u>
Total Rate	0.49482

THIS TAX RATE WILL EFFECTIVELY RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S RATE BY 4.83%.

This year's levy to fund maintenance and operations expenditures exceeds last year's maintenance and operations tax levy.

NOW, THEREFORE, the Brown County Commissioners Court does hereby adopt the stated tax rate. Resolution adopted this the 8th day of September, 2025.
